**ROAD TASK FORCE REPORT:**

Mr. Sivick reported that as part of the project, paving will be done on SR 2001 from Little Egypt to the American Legion.

**PUBLIC WORKS DIRECTOR/ROADMASTER:**

Tim Rohner, Public Works Director / Roadmaster reported repairs were made to trucks and equipment, mowing all township site lines, cleaned up recycling sites, working at the park, mowing at Annex, Township ballfield, ambulance building, park and fire house and picking up trash. Delivered 150 gals of waste oil to Pocono Ranchlands maintenance building. Fixed pipe with black top on Municipal Dr., banners put up for concert at park on 6/25/17. Ehrlich in to spray weeds on Winona Falls Rd., broomed and cleaned up back lot at Township building. PA State inspections done on #917, #921, old #915. New tires on #910, two front tires on #915, two front tires on #909. Broomed Township roads from heavy thunder storm on 6/19, cleaned inlet and outlets of drainage pipes on Minks Pond Rd and Section 5A. Replaced three 15" pipes and one 18" pipe on Minks Pond Rd. Concert at park on June 25<sup>th</sup> went well with around 100 people attending. Safety Kleen in to pick up paint from clean up. Line painters are in painting lines. Lehman Park was broken into on July 1<sup>st</sup>, doors pried open, nothing stolen. Pa State Police were notified. Clean up of trees on Creek Rd and Brodhead from thunder storm over the 4<sup>th</sup> of July weekend. Received new trailer for skid-steer.

Paving to be bid out, flaggers and line painting included in bid.

- 1- 5,400' at 19' wide with 1" scratch coat
- 2- 3,630' at 22' wide with 1" scratch coat
- 3- 1,750' at 19' wide with 2" top

Tar & chip to be bid out. 7.5 miles single application 20' wide.
