1. MONT LAWN CAMP - LAND DEVELOPMENT PLAN:

A new cabin will be constructed following the demolition of an old cabin and two other buildings not being used. The owner has enough funds to construct the cabin, but there are no funds to upgrade the sewage system at this time. There will be a restriction on the number of bunks allowed in the cabin. The system allows for 46 bunks in one cabin, 46 in another and 47 is allowed in the remaining cabin.

The owner will submit to the township a yearly affidavit acknowledging the restriction of bunks as it relates to the sewage capacity. If the owner goes over the allowed capacity, then daily fines will be imposed. Spot inspections will be done the township's zoning and sewage enforcement officers. This will be a condition for approval.

The township's planning commission and the Pike County Planning Commission recommend approval. The Pike County Conservation District has also approved the plan.

Motion made by Mr. Vollmer and second of Mr. Rohner to approve the Mont Lawn Camp Land Development Plan with the condition that the number of bunks is limited to the sewage capacity. A yearly affidavit shall be issued to township, and that spot inspections will be done by the township's zoning and sewage enforcement officers. Unanimous.

The owner also requests a waiver from the Subdivision and Land Development Ordinance.

The request is to not provide profiles for water and sewer. The contractor will make sure that the pressure lines are at the proper depth. The township's planning commission recommends granting this waiver.

Motion made by Mr. Vollmer and second of Mr. Rohner to grant the waiver that the owner does not have to provide the profiles for water and sewer, and that the contractor will make sure that the pressure lines are at the proper depth. Unanimous.
