ROADMASTER/PUBLIC WORKS DIRECTOR:

Mr. Sivick stated that on Sunday, June 28th SR 2001 was closed due to downed Verizon wires. Traffic was detoured through Pine Ridge and Pocono Ranchlands. The Bushkill Fire Company fire police handled traffic flow. Rep. Rosemary Brown had been contacted for assistance. There was a possibility that the repairs would not be made until the following day. Rep. Brown reached out to Verizon, and a crew had been dispatched and the repair made that afternoon.

The crew has been busy with mowing along the road sides throughout the township.

Potholes have been filled on SR 2001. The worst ones have been addressed, and the crew will address the smaller ones shortly.

Drains have been cleaned throughout the township after each storm.

Residents have been dropping off brush for compost recycling at the township. A drop off site is being developed for Pine Ridge residents.

Construction has begun in the community park, which includes a baseball and soccer field, walking trails and parking.

The crew did a lot of cleaning up after the torrential storm of June 30th.

District games for the National Little League are being played on the municipal baseball field. It has probably been over 40 years since this has happened in Bushkill.

The SR 2001 upgrade project is scheduled to go out for bid on July 16, 2015. The supervisors will be pushing for the replacement of the bridge near Pocono Mountain Lake Estates' club house now. This needs to be addressed and not delayed.
