Motion made by Mr. Sivick and second of Mr. Vollmer to award the bid for gabion rock to Eureka Stone Quarry for \$11.00 per ton FOB Plant and \$16.94 per ton delivered. The bid for crusher run is awarded to Dingmans Ferry Stone for \$11.99 per ton delivered. The bid for 3A stone is awarded to Eureka Stone Quarry for \$7.25 per ton FOB Plant and \$13.19 per ton delivered. The bid for blacktop (9.5 mm) is awarded to Eureka Stone Quarry for \$56.46 FOB Plant. Unanimous.

Motion made by Mr. Sivick and second of Mr. Vollmer to approve the sending of a letter to the Pike County Commissioners that the township will consider cost sharing for the 2016 gypsy moth spraying program for the residents contingent on state/federal funding being received. If the county does not receive state or federal funding, then the township will review the bidding process and partnering with the private communities within its borders. Unanimous.

#### 2. CHANGE ORDER No. 1, COMMUNITY PARK PROJECT:

Change Order No. 1 has the following changes to the project scope.

Topsoil will be taken from the local school construction site and will be utilized on the park site. 2,500 cubic yards of topsoil @ \$2.25/cubic yard results in a credit of (\$5,625.00)

- Two (2) concrete headwalls will be placed on the downstream side of the stream crossings.
- Two (2) concrete headwalls @ \$4,595.00 each for a total of \$9,190.00.

A retaining wall will be designed and constructed along both stream crossings. Retaining wall

materials, 697 square foot @ \$10.20/square foot is \$7,109.40. Retaining wall design is \$4,000.00.

The increase in the contract price is \$14,674.40, bringing the new estimated contract price due to this change order will be \$452,695.40.

Motion made by Mr. Rohner and second of Mr. Vollmer to approve Change Order No. 1. Unanimous.
