## 1. SAW CREEK ESTATES – FIRE HYDRANTS

Attorney Bernathy distributed another draft agreement between Lehman Township, Saw Creek Estates Community Association, Bushkill Fire Department and Pennsylvania American Water.

Paragraphs 1 through 8 are acceptable to the Supervisors

Paragraphs 9 and 10, changed the responsibilities from Saw Creek Estates C.A. to Pennsylvania American Water.

Attorney Bernathy will add Paragraph 12 to include money from Saw Creek Estates to be held in escrow, amount to be determined. Each hydrant has a monthly rental fee paid by Saw Creek Estates to Pennsylvania American Water.

Attorney Bernathy will circulate the agreement with changes to the other parties for review.

The Township received calls from three residents asking that anti-skid be put down on their roads. Mr. Rohner explained to them that they are a private community and that could not be done.

Timothy Rohner, Public Works Director/Roadmaster reported that #921 and #910 are back from Whitmore's for repairs and inspection, #915 had two rear tires replaced, fixed and concreted headwall at VanWhy Road, installed insulation and drywall at the park caretaker's house. Crew has been plowing and salting from storms, minor repairs to trucks and plow equipment. PennDOT came in to speak with Tim. They will be doing a traffic switchover from Little Egypt to the American Legion on Wednesday. Work is still continuing from Bear Road up to Pocono Mt. Lake Drive and the "S" turn.

Tim asked who is responsible for the residents to get from their driveway to the temporary road. Attorney Bernathy stated that there must be access agreements between the residents and PennDOT to make sure they have access to the temporary road. Tim will reach out to PennDOT to clarify the situation.
