Tim Rohner, Public Works Director / Road master, reported that the crew has been busy cleaning the trees from recent storms, new alternator on truck #915 (old), head gasket repair to grader, minor repairs

to trucks and equipment. Township roads and intersections were broomed from Section 5A south, truck #914 and bucket truck inspected and passed, pot hole patching and garbage picked up on Township roads. Tax collector papers picked up and taken to recycling center for shredding. Safety Kleen was in to pick up paint and chemicals. Truck specs for new 550 one ton dump (copies given to Supervisors). Spoke to Robert Santoske of PennDOT, District 4, notifying him of pot holes on Milford Road within the construction area. He will take care of it as soon as he gets some cold patch. Leeward opened up the accesses for residents during the storms and the traffic will be switched over within 2 to 3 weeks as long as Verizon moves the poles out of the way. Truck #920 taken to Ray Price Ford for right side manifold (truck is under warranty) and parts are ordered. Working on getting license plates for equipment that need plates. (chipper, trailer etc.)

Mr. Sivick reported that electronics was the topic at the Pocono COG meeting. Taking electronics at the cleanups can be a challenge in the future. DEP mandates are being passed down to the municipalities who absorb the cost and no avenue in the future to dispose of it.
