PUBLIC WORKS DIRECTOR / ROADMASTER:

Tim Rohner, Public Works Director/Roadmaster reported that the men worked on trucks and equipment. All boilers have been serviced at the Township building, Annex and Park. Township ballfield has been weeded. The crew attended an LTAP class at Pike County Training Center. Cleaning up from Fall cleanup days, work at Park setting up for the Halloween Trail. Pocono Spray Patching was back in to re-spray sections of Creek Road, Krump Road and Emery Road. Truck #915 to Whitmore for repairs. Replaced rear tires on Old #915. Mowing Township ballfield. Hanson in to pave roads. Job completed and line repainted on October 17th. Crew putting shoulders on roads in Rustic Acres. Fall clean up on September 22nd and 23rd went well. We used twenty-six 30 yard dumpsters and two 40 yard dumpsters. Shredded 1,570 pounds of paper and took in 190 tires. Back lot was cleaned up in a week, pouring off paint for Safety Kleen is pending. There were no problems or issues at the Halloween Trail on October 14th. Caretaker James worked the event.

SR 2001 update: It is recommended to make phone calls to PennDOT to fix pavement below the Legion at the S turn.
