The Township could appoint this person as Conservator, demolish the dangerous structure and bill the Conservator and ask that the County taxes be forgiven. Attorney Karpowich will send Mr. Rohner information about starting this process, if the County does not cooperate.

7. TIMELINE TO BID AND CONSTRUCT THE LEHMAN PARK TOPSOIL REMEDIATION PROJECT:

PUBLIC WORKS DIRECTOR / ROADMASTER REPORT:

Tim Rohner reported work being done on trucks and equipment, had one truck hauling black top for Oak Grove paving project, cleaned up more scrap from clean up days, cleaned up all intersections on township roads, filling water tank at community garden, cleaning up recycling sites at the township building, Tamiment, Pine Ridge and Ranchlands. DBI was in to spray guide rails and signs, filled potholes in 5A, Sunset Lake Road, and Toms Creek, picked up trash off various township roads, cleaned up trees and brush on Sunset Lake Road from 01 to Log & Twig Road, replaced right side fuel tank on Truck #915, cleaned park office at township park, removed porch from caretaker's house at park, July 4th parade from township building to Legion went well, new Holland mower is in Honesdale for fuel pump repair and service.

<u>Updates</u>: Phone lines on West Sugar Mt. Road by Sunset Acres and North Court still not repaired by Verizon. CAT will be sending their technician for repairs. Waiting for Chemung to do guide rails. Locksmith is expected Thursday or Friday to finish the park locks and re-cylinder two doors at the municipal building. Waiting for Waste Management to pick up three of their dumpsters.
