3. DANGEROUS STRUCTURE – 173 DOVER DRIVE, SAW CREEK ESTATES:

4. LEHMAN PARK TOPSOIL REMEDIATION PROJECT:

5. KASS PROPERTY (DANGEROUS STRUCTURE), THE GLEN AT TAMIMENT:

The township declared this a dangerous structure at the October 5, 2016 hearing. It never made it to the Magistrate's office and has since gone into repository. The township will have to submit a bid to the County to acquire the home in order to tear it down. Even though there has been little to no lot sale activity recently, Davis Chant based an evaluation for this lot on sales over the last 5 years to be between \$ 2,500 and \$5,000, for this particular section in The Glen.
