MINUTES

APPROVE THE MINUTES OF NOVEMBER 13, 2018:

Motion made by Ms. Laino and second by Mr. Vollmer to approve the minutes of November 13, 2018 as presented. Unanimous.

AUTHORIZE THE PAYMENT OF THE BILLS ON LIST #1, LIST #2 AND THE TRANSFERS AS PRESENTED:

Motion made by Ms. Laino and second by Mr. Vollmer to authorize the payment of the bills on List #1, List #2 and the transfers as presented. Unanimous.

ACCEPT THE FINANCIAL STATEMENTS; ALL FUNDS, FOR THE MONTH ENDED OCTOBER 31, 2018:

Motion made by Ms. Laino and second by Mr. Vollmer to accept the financial statements; all funds, for the month ended October 31, 2018. Unanimous.

PUBLIC HEARING – 2019 BUDGET:

Mr. Rohner stated that this is the date (12/11/18), time (10:05 a.m.) and place (Lehman Township Municipal Building) for the Public Hearing for the 2019 Budget.

The advertisement for the hearing was published in the Pocono Record and posted upon the Township building.

The budget for the General Fund will be \$3,063,263.00, Fire Fund \$170,000.00, Emergency Services Fund \$103,865.00, Future Police Fund \$228,025.00 and State Liquid Fuels Fund \$596,342.00. The total budget for 2019 will be \$4,161,495.00. There is an increase from the 2018 budget of \$298,095.00.

There will be no tax increase as the millage remains the same at 6 mills for General Fund, 1 mill for Fire Fund and .333 for Emergency Services Fund.

No public comments were received.

Hearing closed at 10:08 a.m. by the motion made by Mr. Vollmer and second by Ms. Laino. Unanimous.

NEW BUSINESS:

REQUEST OF THE PIKE COUNTY D.A.'S OFFICE – PIKE COUNTY DRUG TASK FORCE FUNDING:

District Attorney Ray Tonkin was present and distributed a funding proposal to the Supervisors. In conjunction with the Pike County Commissioners and the municipalities, he is proposing a full time county detective in the Pike County D.A.'s office dedicated fully to drug law enforcement, dealing with drug traffickers and drug dealers. The County will match dollar for dollar funding from the municipalities, up to approximately \$51,568.00. He would like this individual in his office to have countywide jurisdiction working with the State Police and Municipal Police in the eastern part of the county, to investigate drug traffickers within the county and ones coming from outside the county. A yearly report will be given to each municipality.

There have been positive responses from the municipalities in Pike County. According to the proposal given, Lehman Township's contribution would be \$10,663.00. All contributions will be kept in a separate account with the County. The Supervisors will discuss this proposal and inform Mr. Tonkin of their decision.

PUBLIC WORKS DIRECTOR / ROADMASTER REPORT:

Tim Rohner reported working on trucks and equipment, basement windows installed at the caretaker's house, picking up leaves in Rustic Acres and Minks Pond Road, fixed lights and cleaned gutters at the Annex. Crew was out at 2:00 p.m. for the first snow storm on November 15th. Two break downs during the storm, both had hydraulic line failures. Water lines at the park have been drained, Leeward finished the municipal building parking lot. Jim Foglio is working on stone wall at the park, hauled out fill dirt for stone wall project, cleaned up recycling sites at township building, Pine Ridge, Tamiment and Ranchlands. Decorated township tree and Annex with Christmas lights, hauled out stumps from park, completed work on Bin #3 roof and almost completed Bin #4 roof. Removed tree hanging over roadway on Egypt Mills Road, removed stump and cleaned ditch on Minks Pond Road by Meadowlark Drive. Tree lighting on December 6th went well with a good turnout.

Road Task Force meeting for November was cancelled. Next meeting will be December 20th.

<u>ADDENDUM 1 – SHORT TERM RENTAL PROGRAM:</u>

We received a proposal for a program that tracks short term rentals from STR Helper in the amount of \$12,500. It was decided to table this until we hear from Attorney Karpowich concerning regulating short term rentals from the Pennsylvania Supreme Court.
