# <u>ADDENDUM 1 – PA AMERICAN WATER ROAD BOND AND HOLE ON WINONA FALLS ROAD NOT BEING</u> REPAIRED:

The most recent conversation between Kasey White of Pa American and Brian Winot of Northeast Site, the hole repair is scheduled for the first week in January, as long as Leeward's blacktop plant remains open.

After discussion a motion was made by Mr. Vollmer and second by Ms. Laino to pull the bond and the township will repair the road. Unanimous. A quick fix will be for the township to fill the hole with cold patch and bid the job out as soon as the weather breaks.

Attorney Karpowich will contact the Bond company informing them that the Township will be cashing in the bond and the work will be done by the township.

## ADDENDUM 2 – PA AMERICAN WATER PUMP HOUSES:

Stanley Whittaker, Township Zoning Officer, spoke with Kasey White concerning the dilapidated pump house/treatment plant PA American Water owns and operates in Rustic Acres. Mr. White stated that money is in the 2019 budget to do the demolition of these buildings. One building is across from the firehouse/bus stop and the other is in Section 6 of Rustic Acres. There is an agreement between the previous owners and PA American Water Company to maintain these buildings and utility easements.

Stanley Whittaker will begin the process of issuing to PA American Water Co. a property maintenance code violation for dangerous structures.

### ADDENDUM 3 – PA AMERICAN WATER COMPANY BILLS FOR SAW CREEK ESTATES HYDRANTS:

Dave Martin, Saw Creek Estates' Property Manager, has not returned multiple phone calls from Mr. Rohner. The township wants to know what is being done about recycling provisions for their residents. We also want to discuss the invoices from PA American Water for their hydrants.

3. APPROVE MCGOOEY, HAUSER & EDSALL PROPOSAL (\$40,000) FOR THE BUSHKILL OUTREACH CENTER:

Motion made by Mr. Vollmer and second by Ms. Laino to approve McGooey, Hauser & Edsall proposal (\$40,000) for the design and plans for the Bushkill Outreach Center. Unanimous. Mr. Vollmer will oversee this project.
