PUBLIC WORKS DIRECTOR/ROADMASTER REPORT:

Roadmaster Tim Rohner reported that work on trucks and equipment continues. Two members of the road crew have been working on the new porch roofs at the township building. The recycling sites at Pine Ridge, Ranchlands, Tamiment, and the township building have been cleaned up. The site lines have been mowed. Clean up from Clean Up Days continues. The pot holes on Brodhead Road have been filled; 2 tires and 2 trees have been removed from the road as well. The line painting and painting of the stop blocks has been completed on the township roads. The shoulders have been mowed on the township roads. The crew continues to work at the park. New boards were installed on the new trailer completing the repairs on the trailer. Truck #916 passed state inspection. Trees and brush were cut on Minks Pond Road. Parking space lines were painted at the township building. The zoning vehicle was serviced and passed state inspection. The Road Task Force meeting scheduled for June 18th was cancelled. The next meeting is scheduled for July 16th.
