Motion made by Mr. Rohner second by Ms. Laino to authorize the payment of the bills on List #1, List #2 and the transfers as presented. Unanimous.

NEW BUSINESS:

1. BUSHKILL FIRE COMPANY APPROVAL OF WRITTEN AGREEMENT TO FINANCE A US TANKER TRUCK:

The public hearing was opened at 2:07 PM by Mr. Rohner pursuant to the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended, on a proposal the issuer enter into an agreement to finance certain equipment.

The equipment to be financed consist of One (1) US Tanker Truck (Demo) and will be maintained at the fire station in Bushkill, Pennsylvania.

To finance the costs of such equipment and to pay costs and expenses incidental to the financing, the issuer proposes to enter into a loan agreement with a maximum aggregate principal amount not to exceed \$356,277.00

The issuer will be required to pay all taxes on the equipment. The rental payments due pursuant to the loan agreement will be secured by a security interest in the equipment.

A motion to accept the proposal to purchase One (1) US Tanker Truck (Demo) with a maximum aggregate principal amount not to exceed \$356,277.00 was made by Mr. Springs motion 2nd by Ms. Laino. Unanimous.

PUBLIC WORKS DIRECTOR/ROADMASTER REPORT:

Work continues on trucks and equipment. Clean up from clean up days continues as well. The CAT loader and CAT backhoe were serviced by CAT. The crew worked on mowing site lines and cut trees and brush on Toms Creek Road. Trash and garbage were picked up on township roads. The handicap ramp was finished at the annex. The shoulders on the township roads were mowed. New freezers were

installed at the park for Outreach. Trees and brush were cleaned up and drains were opened from the August 4th storm. Work was done on culvert pipes and shoulders on Brodhead Road. Truck #915 and old #915 have been sandblasted and work continues on the dump bodies for both trucks. The recycling sites at Tamiment, Pine Ridge and the township building have been cleaned up. The fire extinguishers were serviced by Cintas.
