MINUTES

CALL THE MEETING TO ORDER:

Chairman Robert H. Rohner, Jr. called the meeting to order at 3:16 P.M. Also present were Theresa Laino, Vice Chair, Aaron Springs, Supervisor, Ambulance Service Review Committee members Kyle Rohner, Township EMS Director, Sally Bensley, Susanne Duffy, and Edwina Wolfe, Assistant Secretary

PUBLIC COMMENTS:

APPROVE MEMORANDUM OF UNDERSTANDING WITH SUBURBAN:

Motion by Mr. Rohner second by Mr. Springs to approve the memorandum of understanding (MOU) with Suburban EMS. Unanimous. The MOU is a part of these minutes on file.

LEHMAN PIKE EMS DISCUSSION:

The committee discussed the graphics for the ambulances and chase vehicle. Kyle Rohner submitted choices to the committee after the last meeting. Following a discussion, it was decided to use layout #3 of the designs Mr. Rohner submitted and to have the lettering done in gold flake with a black outline. The decals on the back will be fire engine red and charcoal and the leaf and acorn emblem will be gold flake. The back of the ambulances will have red & white chevrons on the box with LEHMAN PIKE on the doors and the star of life on the windows. The front of the ambulances will have AMBULANCE written in reverse. There will be a big open space on the front of the ambulance – it was decided to have LEHMAN PIKE placed in that area. It is unsure if it is required to have the star and rig number put on the top of the ambulances – Mr. Rohner will find out. Mr. Rohner will contact the graphics company to let them know the decisions made by the committee.

The committee discussed what number they would like to use for the station. It was agreed that if they are able to assign the number, they would like 22. Kyle Rohner will find out if the committee is able to assign the number.

Robert Rohner will ask attorney Logsdon to find out if the township needs to go to the Pennsylvania Department of Health to apply to become an ambulance service.

Robert Rohner said that a second demo ambulance will be delivered at the same time as the one ordered from Glick Fire Equipment Company for the Lehman/Pike EMS. It will be identical to the one already purchased. Nick Dewitt from Glick is sending the information about the ambulance to Mr. Rohner. Mr. Rohner has been emailing Tracy Terrest of Volunteer Financing

Services who work directly with Glick regarding financing the 2^{nd} vehicle. Mr. Rohner will reach out again to her to get more details about financing.

The color of the uniforms for the ambulance service employees was discussed. It was agreed to have red shirts and charcoal pants. Mr. Rohner will contact Dempsey Uniform to make arrangements for the uniforms.
