Laurel Center has sold and asked if this property could be added for LERTA consideration. Mr. Logsdon replied the if properties are added there will need to be an amendment to the ordinance. Additionally, the property will need to qualify under the criteria set forth in the ordinance. The school district and county will need to be contacted to see if they agree to adding this property. Mr. Logsdon will draft a letter to the school district and county for the supervisors to review.
